DEFINITIONS

- **ENRICHMENT: MARCH 13. NO GRADING**

CHOICE GIVEN TO FAMILIES AND TEACHERS FOR 2020-21

- **VIRTUAL: ONLINE FOR THE ENTIRE OR MAJORITY OF SCHOOL YEAR**
- **TRADITIONAL => REMOTE: RETURN TO PHYSICAL CLASSROOM**

WHAT IS VIRTUAL SCHOOL?

- **Standards-based curriculum, TK-12**
- **Utilizes a pre-built, online curriculum (EDGENUITY)**
- **Delivered by CNUSD teachers, Coordinated at the District with site support**
- **Longer term commitment (trimester or semester)**
- **Learning schedule is flexible**
- **Attendance taken through software**
- **NCAA, A-G approved, includes SOME programs (GATE, DLI, HONORS, AP)**
- **To the extent the family is comfortable, virtual students may elect to participate in an in-person specialty course not offered in the virtual format (i.e. AVID, Band, Athletics, AP courses not offered), in addition to their virtual courses, as space allows.**

WHAT IS TRADITIONAL SCHOOL COUPLED WITH REMOTE LEARNING?

- **Standards-based curriculum, district core options**
- **Modeled units of study developed and delivered by CNUSD teachers**
- **Learning schedule is teacher paced**
- **Coordinated at the site with district support**
- **Attendance taken by teacher**
- **NCAA, A-G approved, supports special programs such as DLI, GATE, IB, etc.**
- **REMOTE LEARNING: This program is coupled with Remote Learning so if at any point in the school year Public Health Orders force us to close schools due to COVID-19, we can toggle back and forth between Remote Learning and Traditional Schooling.**

NORCO – The Corona-Norco Unified School District Board of Education voted 5-0 at a Special Meeting of the Board last night, August 25, 2020, [approving a contract](#) for Leadership Associates to lead the Superintendent Search in an amount not to exceed \$42,150.

Leadership Associates has many years of proven success in assisting school districts across the state of California in finding top candidates to fill the position of Superintendent of Schools. The Corona-Norco USD utilized Leadership Associates for recruitment of former Superintendents in 2007 and again in 2012.

The consulting services will include community and staff input process and development of candidate profiles; recruiting, reference checking, and candidate application review; and the presentation of candidates, interviews, and selection of the next superintendent.

It is the District's desire to include the community and staff in the process of determining the future leader of the District. Leadership Associates will not only provide that opportunity but will ultimately lead the District on the right path in the selection of the next Superintendent.

Upon the hiring and negotiations of the terms of an employment agreement with the new superintendent, Dr. Lin's responsibilities and annual salary will end.
