Nominations should be submitted to the Association on the Nomination Form no later than **Friday, October 4, 2024**. Nominations will only be considered if on an official Nomination Form. The Board of Directors will select the slate of nominees. The nominees approved by the Board of Directors will be contacted by staff to complete the Candidates Form. The REALTOR® of the Year Selection Committee will select the final recipient of the REALTOR® of the Year Award from those nominees who have completed and submitted the Candidate Form by the deadline. Candidates who do not qualify will not be considered. The REALTOR® of the Year Selection Committee will select the final recipient of the REALTOR® of the Year Award. The top 5 points earners will be selected to attend the Installation as a guest of the Association. The selection of the Recipient of the Award remains confidential until the Installation celebration. More detailed information about this special event will be available later.

## Nominations for REALTOR® of the Year Award

Awarding the prestigious REALTOR® of the Year Awards has been a very welcome addition to our Installation Event. We need your help in making this award possible. You are invited to nominate REALTOR® members from any office whom you believe to be deserving of a REALTOR® of the Year Award. The nominee must be a current REALTOR® of The Inland Gateway Association of REALTORS®. Nominees will be awarded points based on the following criteria:

REALTOR® of the Year Award:

- Association Involvement {Maximum Points – 50}
- C.A.R. Involvement {Maximum Points – 5}
- N.A.R. Involvement {Maximum Points – 5}
- TIGAR (or formerly EVAR) Events – {Maximum points - 19}
- Community Involvement {Maximum Points – 20}
- Actively in the Business {Maximum Points – 10}
- Professional Excellence – Training and Education that the REALTOR® takes on his/her own accord to become more knowledgeable. Designations (Maximum Points – 5)
- Professional Reputation (REALTOR® who best exemplifies the REALTOR® spirit – high principles of integrity, adherence of the REALTOR® Code of Ethics and furtherance of the principles of real estate practice among brokers, agents and the general public
